## **SOCIETY'S CEMETERY PROJECT NEARS** COMPLETION

The preservation of Charles County's heritage has always been an important objective of The Historical Society of Charles County. In light of this, the Historical Society has transcribed over nine-thousand tombstone inscriptions including forty-one public cemeteries and seventy-seven private cemeteries on wooded property, being lost to development and natural overgrowth.

The first cemetery committee of the Society was formed in the 1960's under the direction of Elinore K. Warren. This committee began the task of locating and transcribing both private and public cemeteries in Charles County. Later, extensive work began with the leadership of Watson Perrygo, John Hanson Mitchell and W. Preston Williams.

The present committee, under the direction of Michael J. Mazzeo, Jr., was formed in 1978 under the guidance of Velva Perrygo and, with the support of

George C. Dyson, involved not only numerous members of the Historical Society and the general public, but also students from La Plata High School with their Community Based Learning and Service Program. The completion of this project was realized in 1984 and a subsequent computerized name-index, containing over 15,000 names, was made possible through matching grants from The Charles County Heritage Commission and The Historical Society of Charles County.

The members of the Cemetery Committee have spent countless hours transcribing and typing tombstone inscriptions in order to make them available to the public. They are indebted to many people, especially the Officers and Board of Directors of The Historical Society from 1978 through 1986, The Charles County Heritage Commission and the Learning Resource Center Staff of the Charles County Community College.

It is with great pride that the Historical Society completes this research, for this project will not only benefit genealogists and researchers of today, but will help preserve the Heritage of Charles County for the future.

## BRENT

To the memory of Louisiana, who was born upon the 1st of March 1829 and died at Pomonkey Charles County, Maryland upon the 15th of September 1830 aged one year, six months and thirteen days. This stone is erected by her affectionate parents William L. Brent and Maria Fenwick, his wife, "The Lord bless thee and keep thee" Numbers Chapt. V6 V183

To the memory of William Leigh Brent who was born at Martinsville in the state of Louisiana upon the 28th of September 1820 and died at Washington City D.C. upon the 17th of March 1833 aged twelve years, five months and seventeen days. This stone is erected by his mourning and affectionate Father and Mother, William L. Brent and his wife, Maria Fenwick.

No early care had worn the tender ties that bound him here no grief his heart had bowed, only to pure for earth, he seemed to rise, to his own heaven doth some silver cloud before the winds grow loud. He's gone! He's gone! in silence make his grave but not in tears we would not from its home, recall his happy soul perchance to brave away lot too gentle far to roam through years of grief to come. Oh God! 'Thy will be done in this and in all things for thou art mercy itself and tenderly tempers the wind to the shorn lamb'

# NEWLY FORMED COUNTY HISTORICAL SOCIETY PLANS PROJECTS

The Times Crescent - May 31, 1962

Following cocktails and a beef dinner, the Historical Society of Charles County, Inc., held its first general membership meeting at Benedict Pier, Wednesday, May 23. More than eighty members attended.

F. DeSales Mudd, master of ceremonies, introduced Charles E. Fenwick, president of St. Mary's County Historical Society, and his wife; Mrs. Edward H. Forney, Washington genealogist and D.A.R. regent; and Norbert G. Mudd of Richmond.

Dr. Reginald V. Truitt, past president of Queen Anne's County Historical Society, spoke of the rich historical background of Charles County and the challenge to a County Historical Society.

Dr. Truitt listed many subjects for research and lecture work:

- 1. Missionary work among Indians;
- 2. Great men such as John Hanson, Thomas Stone, Daniel of St. Thomas and General Smallwood;
- 3. Homes, manor houses, churches and original grants;
- 4. Cullinary accomplishments;
- 5. Collection of graveyard records;
- 6. Indians and their relics:
- 7. War records;
- 8. Local legends;
- Photographic record of antiques and county homes;
- 10. Significance of place names;
- 11. Acquisition of permanent home;
- 12. Establishing a museum

Guy W. Weatherly, Senior Archivist of the Hall of Records in Annapolis, told "What the Hall of Records means to the Citizens of Maryland," He invited the society to make use of the largest collection of colonial governmental records in the United States.

The gavel was then turned over to Bennett Crain, president, for a regular membership meeting. He announced the officers for the coming year: Vice-President, Eugene Jenkins, Jr., Secretary, Mrs. Edward J. Edelen; Treasurer, Mrs. Samuel C. Linton, Sr.

Directors will be: Robert T. Barbour, Judge John Dudley Digges, Francis I. Ferrall, Admiral Frank J. Fletcher, Mrs. Worthington S. Kemp, Mrs. George H. Matthews, Miss Louise Matthews, James C. Mitchell, John H. Mitchell, F. DeSales Mudd, Lemuel Wilmer. The treasurer reported 252 members.

Mr. Crain announced that the next regular meeting of the membership would be in October. Plans are underway to establish a permanent headquarters for the society.
